**Finance report**

During the fiscal year that ended last June 30, 2021, EPA had income of \$186,040 and expenses of \$159,352, for a net gain of \$26,688. For the current fiscal year, which ends June 30, we are projecting a modest loss. There should be about \$86,000 in equity cash at the end of the current fiscal year.

**Scholarship report**

Jerry Jenkins presented the \$2,000 Jerry Jenkins journalism scholarship to Radha Vyas, a student at Dallas Theological Seminary. Douglas J. Trouten Memorial Scholarships in the amount of \$750 each were awarded to Zoe Ross of John Brown University and Samantha Leon of Hannibal-LaGrange University who plans to attend Taylor University this fall.
