Seconded.

Lamar projected a slight deficit for FY26 budget.

Increase HRA

Sandra Glahn informed Lamar Keener that the Board voted in Executive Session to increase the annual allotment for the Section 105 HRA from \$10,000 to \$12,000 and to reduce the director's salary from \$70,000 to \$68,000, effective July 1, 2025.

2027 Convention

Board directed Lamar Keener to explore Cleveland, Chicago, and Pittsburgh for Convention 2027.

Fall Planning Retreat

Board requested a revised budget that adds \$7,000 for an in-person board meeting in the fall.

FY26 Budget

Motion by Sandra Glahn: to give preliminary approval for the 2025-2026 with the modified budget including a \$7,000 addition with review and final approval at the fall board meeting.

Seconded.

Motion carried.

New business

Magazine Training International

The Board discussed asset acquisition proposal of Magazine Training International.

Motion by Sandra Glahn: to authorize the Executive Director to take whatever actions necessary to execute an asset acquisition agreement with Magazine Training International.

Motion carried.

Motion by Lamar Keener: to open a bank account under the name of MTI as a DBA of EPA.

Seconded.

Motion carried.

Screenwriter Membership Initiative

The Board discussed whether to add screenwriters to list of potential members for EPA. The Board distinguished the need to differentiate between nonfiction and fiction for any category of member we may add. The Board discussed other visual non-fiction storytellers that could potentially be added for membership.
